4. The Museum does not allow image modification or out of context representation.
5. Special requests will be considered and are subject to special agreements. We reserve the right to charge additional fees for items that pose unusual difficulty in scanning or reproduction.
6. There will be a 10% overhead charge for extended research projects in addition to the hourly rate, the reproduction fees, and other fees detailed below. Each extended research project will have a special agreement / contract to include scope of work to be preformed, as well as project timelines and milestones.
